Terms and Conditions of the Player Development Program (PDP) Agreement:

The term of this PDP Agreement is a month-to-month and shall be issued in the name of the member. Either party may terminate this Agreement by giving thirty (30) days advance **written notice** of termination. PDP Member is responsible for all fees incurred during the thirty-day (30-day) notice period, regardless of which party elects to terminate.

Benefits may be extended to immediate family (spouse and dependent children 18 or younger living in the same household) for an additional monthly fee as stated below. Member acknowledges that children under 16 years of age must be signed into the Club by a parent or guardian, and children under 11 years of age must be accompanied by a parent or guardian while at the Club.

Member agrees to maintain a current credit card account in Members name on file with the Club and permits club to bill that card for monthly dues and all monies owed to the club. Member agrees to immediately notify the Club of any changes in credit card information. Member further agrees that the Club is not responsible for any fees incurred as a result of the Club billing Member's credit card (i.e. overdrawn accounts, exceeding credit limits, etc.).

Membership benefits and/or rates may not be combined with any other offer, discount, promotion, or special. Not valid with group play, leagues and/or tournaments except as specifically designated by management. Tee times subject to availability. **Cart fees apply if cart is used. \$13 cart/access fee required for 1 hour prior to twilight rounds on regulation course.** Membership benefits and/or green, cart or range fees are subject to change without notice. Members must show membership card to receive benefits. Membership card and benefits are not transferable and have no cash value. Members must abide by all golf course rules.
